

This collectively helps to conserve approximately 1.29 million acres of Belize's biodiversity, and through this, improves the lives of thousands of stakeholders. 

ACTIVITY HIGHLIGHTS



Ministry of Economic Development in Protected Areas

On January 6th, 2022, the Association of Protected Areas Management Organizations (APAMO) hosted Dr. Osmond Martinez, CEO of the Ministry of Economic Development; and Mr. Carlos Pol, Director of the Climate Finance Unit on a site visit to the Billy Barquedier National Park (BBNP) and Mayflower Bocawina National Park (MBNP). The objective of the meeting was to demonstrate, first-hand, some of the onthe-ground realities and dynamics of non-governmental conservation organizations in their mission to support the government's national development objectives.



APAMO Embraces A New Partnership With BTB

On February 2nd, 2022, APAMO (Association of Protected Areas Management Organizations) and the Belize Tourism Board (BTB) signed a Memorandum of Understanding (MOU) to strengthen cooperation in the sustainable development of Protected Areas (PAs) in Belize. This partnership aims to enhance marketing efforts, destination planning, training and certification, and data sharing. The MOU marks a historic collaboration not only for APAMO but for Conservation-Non-Governmental Organizations in Belize, as it actively involves the tourism sector in promoting and preserving PAs as sustainable tourism destinations.



Strengthening APAMO'S Ranger Force

As a follow-up on the partnership between APAMO and the Belize Institute of Search and Rescue Training back in December 2021, both entities have united efforts towards operationalizing a comprehensive Ranger Training Programme. Launched in January 2022, the mission of this programme is to build an effective and robust Ranger force. As custodians of Protected Areas, it is critical for Rangers to develop, enhance and sustain the skills needed to save lives, especially in treacherous and remote conditions.



APAMO Raising Awareness on Watershed

In March 2022, APAMO along with the Belize Audubon Society (BAS) sponsored the Sho family, in the La Ruta Maya Belize River Challenge under the name "Audubon Green Guardians." The La Ruta Maya River Challenge has become a competitive sport, but it also serves as a unifying event for Belizeans, rallying them for a common cause. APAMO and BAS took this opportunity to sponsor this team and build awareness on the importance of protecting our watersheds. Their teamwork and determination to complete the race were truly inspiring. They achieved a commendable 19th place overall and 7th place in the Family Adventure category, completing the race in 20 hours, 58 minutes, and 28 seconds.



APAMO Staff Joins Highway Clean-up

As a part of the International Day of Forest 2022, APAMO joined the Forest Department and other entities in a highway cleanup extending from the Belize Zoo to Guanacaste National Park! Keeping our highways clean is not only important because it ruins the "view", but litter degrades the environment, it attracts vermin and it also endangers people & wildlife.



ACRC Participated in the Capacity Building for PACT as a GCF National Direct
Access Entity Workshop

Ms. Sheila Gomez, APAMO's Business Development Officer, participated in a 3-day Capacity Building Training organized by PACT under the GCF Readiness Project. The training aimed to enhance APAMO's capacity in the GCF, enabling them to utilize these tools and skills for future GCF projects while also strengthening ACRC's capacity. The training, facilitated by consultants from E. Co. LTD, covered topics such as Environment, Social and Gender Risk Identification, GCF Project Management, and Project Monitoring and Evaluation.

Working Relationship with the Ministry of Sustainable Development

The Association of Protected Areas Management Organizations (APAMO) met with the National Biodiversity Office (NBIO) to discuss the APAMO Green Climate Fund (GCF) Concept Note under the hospice of the Protected Areas Conservation Trust (PACT) as the Accredited Entity to the GCF and the Ministry of Economic Development (MED) as the National Designated Authority to the GCF.

The APAMO Central Resource Centre (ACRC) team, in collaboration with the Mayflower Bocawina Environmental and Development Group - MBEDG and a Silk Grass community volunteer, completed a two-day activity conducting a Knowledge Attitude and Practice (KAP) Survey in the community of Silk Grass Village, Stann Creek. The objective of the Mayflower Bocawina Environmental and Development Group (MBEDG) was to assess the knowledge, attitudes and practice of the Silk Grass Village as they are one of the buffering communities of the Mayflower Bocawina National Park.



APAMO/BISART Summer Camp

The Belize Institute of Search and Rescue Training (BISART) and the Association of Protected Areas Management Organizations (APAMO) hosted their first ever joint summer camp at Five Blues Lake National Park near Mile 32 on the Hummingbird Highway. The event was organized with the theme "In partnership, sowing the seeds to appreciate nature to make a better Belize" and youths from seven to fifteen years old participated in the camp. This summer camp first made public view in early July featured on the LOVE FM Morning Show. During their one-hour interview, BISART discussed their upcoming summer camp, and their partnership with APAMO. The activities included basic first aid, jungle skills, nature hike, bird watching, tent assembly, camp fire and wilderness navigation. BISART/APAMO intend to create this camp as a yearly event.


